
DESCRIPTION

One 2nd Floor office situated within the city centre, office 8 is suitable for around 1-2 persons. The accommodation is accessed via a shared hallway and stairway and has use of communal kitchenette and toilet facilities to the first floor.

The premises are fitted out to a good standard and are inclusive of all desks, chairs and the like. There are telephone points, broadband and computer cabling etc. in place. There is also an intercom system that enables the occupier to allow visitors entry into the building.

LOCATION

The office is located on Castlegate, overlooking St Mary's Church and The Coppergate Centre. The area is mixed use in nature and occupiers include Fairfax House, Topshop, Fenwicks, The Jorvik Centre along with several car parks.

TERMS

The office is available on a fully serviced arrangement (except as to reception/staffing) and on a flexible lease at a rent of £275 per calendar month, payable monthly in advance. The rent is fully inclusive of business rates, water and sewerage charges, building insurance, lighting and heating, cleaning and all office furniture.

A deposit of one months rent will be required. The length of the lease is negotiable subject to a minimum of 1 year, thereafter terminable at any time by 3 months prior notice by either party. The term of the lease will also be negotiable up to a period of 3 years. The letting will be excluded from the security of tenure provision of the Landlord and Tenant Act 1954.

VALUE ADDED TAX

VAT is payable on the rent, which will be charged at the prevailing rate.
