The property is easily found on Micklegate. Passing through Micklegate Bar the property is on the left-hand side less than 100 yards. Toft Green is accessed from Micklegate, immediately after Micklegate Bar, turn left following the road around on the property is less than 100 yards on the right.

Description

The substantial three story storey brick façade with glazed display windows and entrance doors to Micklegate. Sizeable basement. Access to rear yard. Toft Green frontage - two storey façade with the delivery entrance to street extending to rear with single story storage space plus in a two storey section with former lounge bar. Rear yard area with outbuildings.

Outside - there is an enclosed yard between the Micklegate building and the former Brewery. This is used for gaining access to the ground floor storage areas, for deliveries to the former bar and restaurant. Additionally, various outbuildings used for general storage.
